## Graph of bitcoin price over all time in Coinbase





### **Greece GDP vs Debt**





Okay, I managed to get things going with Coinbase. I've initiated a transfer into my account, which will take **1**-3 days to clear. Then I can pay the invoice (hopefully). For the record—and I'm sure this won't surprise you—I'm not super happy with this process. My bank won't allow me to use my Irish card to add to my account (it is repeatedly declined because coinable doesn't support my banks verification system), so the best I can do is make a bank transfer that takes a few days and hope that the value of bitcoin hasn't changed dramatically in that time. I'm unable to use any of my American banks/cards because Coinbase made me go through loads of hoops just to prove where I actually reside. I totally understand crypto is where you're at, but if there's any way we can simplify the process I'd be extremely grateful.






