"Many students complete the additional 30 hours with a master's degree, but every student has a different story. For those not sold on a graduate degree as their preferred option, remember that there are many pathways to licensure—community college; a secondary major or minor in a topic you enjoy; a graduate degree in another program. The options are out there if you look for them.

Talk to your peers. Research your options. Go to networking events and ask current CPAs how they did it. Figure out what works best for YOU and go for it. The profession needs your creativity, your ideas, and your insights!"


